| Dispensing | SikaGrind®-100 Activator is added into the grinding mill (first or second compartment), onto the clinker feeding channel or sprinkled / dropped onto the clinker (raw material) on the conveyor belt. Suitable dosage pumps with adjustable flow rates should be used for accurate dosing. Note: Periodically, the end of the additive tube should be checked to ensure, that it is not blocked with cement clinker/dust. |
| Compatibility | Cements treated with SikaGrind®-100 Activator are compatible in concretes produced with all commercial admixtures including air entrain- ers, water reducers, retarders and super plasticizers.
